It is hereby notified for general information that, on 2 May 2006, Her Excellency the Governor, in the name and on behalf of Her Majesty, assented to the undermentioned Bills passed by the Legislative Assembly of Queensland in Parliament assembled, viz—

A Bill for an Act to amend the *Child Protection Act 1999*, the *Child Safety Legislation Amendment Act 2005* and the *Commission for Children and Young People and Child Guardian Act 2000*

Short title: *Child Safety (Carers) Amendment Act 2006*
— Act No. 17 of 2006

Commencement: (1) Sections 40 and 42 are taken to have commenced on 17 January 2005 immediately after the *Commission for Children and Young People and Child Guardian Amendment Act 2004* commenced.

(2) The following provisions commence on 31 May 2006—

- part 2
- sections 30 to 39, 41, 43, 44, 46, 47, 53, 55 to 57
- the schedule.

A Bill for an Act to amend the *Racing Act 2002*

Short title: *Racing Amendment Act 2006* — Act No. 18 of 2006

Commencement: This Act, other than sections 3 and 9, commences on 1 July 2006.

A Bill for an Act to amend the *Consumer Credit (Queensland) Act 1994* to make changes to the Consumer Credit Code, and to amend the *Trade Measurement Act 1990* and the *Trade Measurement Administration Act 1990*

Short title: *Consumer Credit and Trade Measurement Amendment Act 2006* — Act No. 19 of 2006

Commencement: This Act, other than section 5, commences on a day to be fixed by proclamation.

A Bill for an Act for the establishment, management and use of recreation areas, and for other purposes

Short title: *Recreation Areas Management Act 2006* — Act No. 20 of 2006

Commencement: This Act commences on a day to be fixed by proclamation.
